From airport check-in to arrival, we take every step to ensure your child is safe and comfortable during the entire journey. An unaccompanied minor is any young passenger aged between 5 to 12 and not travelling with an adult (18 years or older) on the same flight and class of travel. To ensure our service meets your need, please read the following information carefully and complete this form. All required documents are advised to submit to our branch office at least 72 hours before the flight departure. After assessment, you will be notified the result in a timely manner.

<ol style="list-style-type: none"> <li>1. Tickets of unaccompanied minors are applied to eligible adult fares, and UM shall not be accepted for travel in business classes.</li> <li>2. To apply for this service, parents or legal guardians must <u>complete this form and attach copies of their ID cards or passports and documents that can prove their relationships with the unaccompanied minors (such as Household Register, or its copy).</u></li> <li>3. I declare that I am the parent or guardian of the above mentioned minor, and I am hereby giving my consent and permission for the minor to travel unaccompanied with China Airlines and/or Mandarin Airlines.</li> <li>4. I agree to release the agents and employees of China Airlines and Mandarin Airlines from any and all liabilities for the custody of the minor during the above-mentioned flight, and I certify that the minor will be met on arrival at the point of destination by an adult having responsibility for the custody of the minor. If the minor is not met on arrival, China Airlines and Mandarin Airlines are authorized to take whatever action they consider necessary to ensure the minors' safe custody including return of the minor to the point of original</li> </ol>	

departure by any first available means of transportation. I also agree to indemnify and reimburse China Airlines and Mandarin Airlines for the costs and expenses incurred by them in taking such action.

I declare all the information provided in this form are true and correct, and I agree that the personal data provided in this form may be processed and used by China Airlines and Mandarin Airlines for the purpose of handling carriage of unaccompanied minors. China Airlines and Mandarin Airlines will not reveal any personal information to any third parties not related to this service or transaction without consent. In order to satisfy the purpose of collecting information, and China Airlines and Mandarin Airlines' legal and commercial purposes or related business requirements, China Airlines and Mandarin Airlines will continue to keep the customer information for the necessary time. When destroying customer data, we will adopt commercially reasonable and technically feasible measures in accordance with relevant laws to ensure that the personal data cannot be returned or cannot be reproduced.
