

Consent & Release for Carriage of Unaccompanied Minors

China Airlines and Mandarin Airlines accept unaccompanied minors on international operating flights. From airport check-in to arrival, we take every measure possible to assure your child's safety and well-being during the journey. (This service is only available on flights operated by China Airlines or Mandarin Airlines when other airlines are involved in the journey.) An unaccompanied minor is any young passenger aged between 5 to 11 and not traveling with a legal guardian (parents) or an adult who is at least 18 years old on the same flight and class of travel. To ensure our service meets your need, please read the following information carefully and complete this form. All required documents are advised to submit to our branch office at least 72 hours before the flight departure. After assessment, you will be notified the result in a timely manner.

To apply for this service, parents or legal guardians must <u>complete this form and attach copies of minor's passport</u>, parents' / legal guardians' ID cards or passports and documents that can prove their relationships with the unaccompanied minors (such as Household Register, or its copy).
- 3. If the unaccompanied minor's itinerary involves the flight which is operated by other airlines, the parents or legal guardians must contact those airlines to confirm applicable restrictions and rules before commencing on the journey, as regulations and rules of each airline may differ. If the unaccompanied minors are refused carriage by the other airlines, the parents or legal guardians should bear all liabilities.
- 4. I declare that I am the parent or guardian of the above mentioned minor, and I am hereby giving my consent and permission for the minor to travel unaccompanied with China Airlines and/or Mandarin Airlines.
- 5. I agree to release China Airlines and Mandarin Airlines' agents and employees from any and all liabilities for

the custody of the minor during the above-mentioned flight, and I certify that the minor will be met at the point of destination by an adult with custody of the minor. In addition, I have confirmed with the relevant authorities of the departure, transit and destination countries/regions that all essential entry, exit, and transit paperwork are correctly prepared. If the minor is not met upon arrival or is denied entry due to a lack of required documents specified by the destination, China Airlines and Mandarin Airlines are authorized to take whatever action they deem necessary to ensure the minors' safe custody, including returning the minor to the point of original departure by any available means of transportation. I also agree to indemnify and reimburse China Airlines and Mandarin Airlines for any costs and expenses they incur as a result of this action.

6. I hereby declare that all the information provided in this form is true and correct. I also agree to the latest version of the privacy protection policy and statement as found on the official websites of China Airlines and Mandarin Airlines. Furthermore, I consent to the processing and use of the personal data provided in this form by China Airlines and Mandarin Airlines for the purpose of handling the carriage of unaccompanied minors. China Airlines and Mandarin Airlines will not reveal any passenger's personal data to unrelated third parties without consent, and shall ensure that data subject may exercise their rights under applicable laws with respect to their personal data, including but not limited to the right to inquire, supplement, correct, or delete the data. To fulfill the transportation needs for unaccompanied minors travel and meet the necessary business requirements of China Airlines and Mandarin Airlines, customer personal data will be retained for a reasonable period of time. When the aforementioned purposes and requirements are no longer applicable or relevant, China Airlines and Mandarin Airlines will securely destroy the customer's personal data in a timely manner and will take commercially reasonable and technically feasible measures, in compliance with applicable laws, to ensure that the passenger's personal data cannot be returned or reproduced.
